- The Board approved all fully accredited CODA pediatric residency programs as meeting the requirements of 38-1141(c)(i) and (ii) for minimal sedation or moderate sedation.  
**Note: Submit a copy of the certificate demonstrating completion of the residency program or an affidavit from the program stating that minimal sedation training was included during your residency program.**

**Note: Submit a copy of the certificate demonstrating completion of the residency program or an affidavit from the program stating that minimal sedation training was part of your residency program.**
- Education/training received while attending dental school will be accepted if education/training was completed after July 1, 2011 or if you completed this training prior to July 1, 2011, then you would need to provide proof of attending a continuing education course on minimal sedation.  
**Note: Submit an affidavit from the program stating that you have had minimal sedation training during the program.**
