REGULATIONS UPDATE

There were no updates on Regulations currently.

BOARD DISCUSSION on TITLE PROTECTION

Amy Reynoldson and Paul Henderson with the NMA also joined the Board on this discussion.

It is vitally important that there is transparency for the public at large to know and understand who will be involved with their healthcare.

In Nebraska when a healthcare professional identifies themselves as a "Doctor" if they are not a "Physician" (only licensed Medical Doctors or Doctor of Osteopathic Medicine are able to use the title of "Physician") then they need to further identify themselves to the public/patient. For example, that they are a "Doctor of Podiatric Medicine" or "Doctor of Dental Surgery" or "Doctor of Nursing Practice", etc.

The differences between various types of health care providers can be confusing. It is not appropriate to have confusing or misleading health care advertising or marketing materials that have the potential to put the safety of the public/patient at risk.

Amy shared with the Board the AMA (American Medical Association) "Truth in Advertising" campaign and the results of their surveys. The survey identified that:

- 1) Patients are not sure who is and who is not a physician
- 2) Patients strongly prefer physicians to lead the health care team
- 3) Patients want their health care professional to clearly designate their education and training
