CRDTS PRESENTATION ON TYPODONT TEETH

Dr. Sam Jacoby, President, and Dr. Mark Edwards, Director of Dental Examinations for CRDTS presented information regarding CRDTS uses of typodont teeth as part of their clinical examination. Dr. Jacoby explained that CRDTS has not had a patient based examination since COVID started. He explained that he was not a proponent of manikin examinations but has seen some benefits to the simulated examinations and reminds everyone that both endodontics and fixed prosthodontic examinations have always used typodont teeth. There have been losses when using typodonts during examinations such as the periodontal head and neck evaluation which was replaced with an Objective Structured Clinical Examination (OSCE) on a tablet onsite at no charge and in restorative, the dental diagnosis and treatment planning there is a written examination at no cost. This examination includes at least 4-6 cases which includes dental health history, x-rays and/or CTs (if applicable) and providing a diagnosis and developing a treatment plan for endodontics and evaluates the candidate's ability to diagnose and treatment plan these cases correctly. The typodont teeth developed by CRDTS have enamel, dentin and decay that looks and feels the same as natural teeth. Taking a CRDTS simulated examination allows all candidates to be on a level playing field in a controlled environment since the CRDTS typodont teeth have standardized areas of decay and no modification requests are required. The candidates must use their own diagnostic and technical skill to prepare the teeth without the guidance of modification requests. The dental and dental hygiene periodontal examination is the same however the scaling points grading weight may change. CRDTS uses Brett Foley, PhD, Psychometrician from Alpine Testing Solutions. All examiners are calibrated at the exam site. CRDTS examination criteria are currently being used for remediation and can be customized per individual needs. CRDTS is also exploring virtual haptic technology which can be used to train and remediate students and deficient licensees. The CRDTS office in Topeka, Kansas is building an eight chair simulated clinic which will be available by June 2022 for remediation and testing. Decatur, Alabama and Hastings, Nebraska hygiene programs have simulation clinics for their students. CRDTS has contracted with these schools to use their clinics as independent test sites. These simulation clinics could also be used for hands on continuing education. The Board thanked Dr. Jacoby and Dr. Edwards for the information they provided.

Dr. Guy Champine presented information regarding the Simulated Patient clinical examinations by CDCA/WREB. CDCA/WREB administers a national uniform initial licensure examination with universal portability which increases fairness, uniform preparation, students do not have to worry about what examination to take, and schools will have an easier time hosting an

examination. Additional assessments are available to State Boards such as Restorative including for EFDAs and Dental Hygienists, Dental Therapy, Local Anesthesia (both didactic and/or clinical), Nitrous Oxide, Sedation, jurisprudence, and customized assessments based on State dental board's needs. CDCA/WREB uses CompeDont simulated teeth for their clinical Simulated Patient dental examinations and SimProDH for their Simulated Patient clinical dental hygiene examinations. Information was presented on exam performance and portability. The Board thanked Dr. Shampaine for the information provided.
