DEPARTMENT OF AGRICULTURE UPDATES

Kaylie Fritts, DVM, Deputy Nebraska State Veterinarian with the Agriculture Department was present for discussion with the Board.

NPAI (Highly Pathogenic Avian Influenza) has been detected in dairy cattle in other states, however, to date no detections have been made in Nebraska.

No bovine mortalities have been reported to date.

One human case has been documented with conjunctivitis.

HPAI seems to be decimating the marine mammals wildlife population.

2024 LEGISLATION UPDATES

<u>LB16</u> - Require occupational boards to issue certain credentials based on credentials or work experience in another jurisdiction, provide and change requirements regarding applicants with a criminal conviction, provide for jurisprudential examinations and appeals, change requirements for membership of the State Electrical Board, and adopt the Interior Design Voluntary Registration Act

Approved by the Governor on March 5, 2024.

LB910 - Authorize an emergency medical service to transport and emergency care providers to provide emergency medical care to injured law enforcement canines.

REGULATION UPDATES

The Board continued the discussion regarding the need for Veterinary Technicians especially in the field of large animal veterinary practices and the possibility of amending the scope of practice to include additional procedures for Veterinary Technicians in the Nebraska Veterinary Medicine and Surgery Regulations, Title 172 Chapter 180.

Megan Kilgore, Executive Director of the Nebraska Veterinary Medical Association (NVMA) sent the survey questions from the Board to the NVMA constituents and all Nebraska licensed Veterinarians and licensed Veterinary Technicians to solicit their feedback responses.

Megan has provided the Board with the survey responses.

One response that came up often was to allow Veterinary Technicians to administer the Rabies Vaccine.

Currently the administration of the rabies vaccine is a task that is solely reserved for a Veterinarian.

BOARD DISCUSSION(S)

A. AABP (American Association of Bovine Practitioners) Guideline for Credentialed Vet Techs in Bovine Practice

The Board currently has no comments.

B. RVMA (Relief Veterinary Medical Association) Temporary license for DVM's for relief purposes
The Statutes Relating to the Veterinary Medicine and Surgery Practice Act already allows for a
Veterinarian Locum Tenens licensure. Therefore, there is no need in Nebraska to create a
Temporary DVM license classification.

38-3335. Veterinarian locum tenens; issuance; requirements; term. When circumstances indicate a need for the issuance of a veterinarian locum tenens in the State of Nebraska, the department, with the recommendation of the board, may issue a veterinarian locum tenens to an individual who holds an active license to practice veterinary medicine and surgery in another state if the requirements regarding education and examination for licensure in that state are equal to or exceed the requirements regarding education and examination for licensure in Nebraska. A veterinarian locum tenens may be issued for a period not to exceed ninety days in any twelve-month period. Source: Laws 2011, LB687, § 3.

C. NAVLE (North American Veterinary Licensing Examination) program updates
The testing windows for application to test for the NAVLE will be updated.

PRACTICE QUESTION(S)

A. What is the scope of practice regarding "Pulsed Electromagnetic Field Therapy" for animals?

It is the opinion of the Board that Pulsed Electromagnetic Field Therapy would be within the scope of practice for Veterinary Medicine and Surgery in accordance with 38-3312-1 38-3312. Practice of veterinary medicine and surgery, defined. Practice of veterinary medicine and surgery means: (1) To diagnose, treat, correct, change, relieve, or prevent animal disease, deformity, defect, injury, or other physical or mental conditions, including the prescription or administration of any drug, medicine, biologic, apparatus, application, anesthetic, or other therapeutic or diagnostic substance or technique, and the use of any manual or mechanical procedure for testing for pregnancy or fertility or for correcting sterility or infertility. The acts described in this subdivision shall not be done without a valid veterinarian-client-patient relationship;
