May 19, 2023

REVIEW OF THE UCA (UNIFORM CREDENTIALING ACT)

The Board discussed the importance for all licensees to be aware of the Nebraska UCA, which are the Statutes, the basic law, rules, and regulations for the privilege of holding a credential. Many of the Board voiced that before they were Board Members, they were not fully aware of the importance.

38-103. Purposes of act. The purposes of the Uniform Credentialing Act are (1) to protect the public health, safety, and welfare by (a) providing for the credentialing of persons and businesses that provide health and health-related services and environmental services which are made subject to the act and (b) the development, establishment, and enforcement of standards for such services and (2) to provide for the efficient, adequate, and safe practice of such persons and businesses. To provide for compliance with the provisions of the Uniform Credentialing Act, Rules and Regulations the DHHS Division of Public Health Investigations Unit is responsible for investigating complaints against health care professions and occupations.
