8. UPDATES AND REPORTS

a. Nebraska Chapter of the American Massage Therapy Association (NAMTA) http://www.amtane.org

The following was reported:

- It was reported that the Chapter would like the name on the agenda to be accurately named as: AMTA-NE rather than 'NAMTA'.
- Membership is up; over half the licensed massage therapists are now members
- The national conference is scheduled for 8-22-2022
- No new legislation at this time, they are discussing updating the definition of massage.
- · Compact conversation.

b. Federation of State Massage Therapy Boards (FSMTB) https://www.fmtb.org

Carper announced the annual conference is Oct 18-20 in Charlotte, NC.

MOTION: Roberts moved, seconded by Carstens, to approve Carper to attend the 2022 Annual meeting and have the cost of registration paid by the board. A voice vote was taken. Voting aye: Carper, Carstens, Roberts (3). Voting nay: None (0). Absent: Helaney (1). Abstained: (0) Motion carried.

The Council of State Governments (CSG) is partnering with the Department of Defense (DoD) and the Federation of State Massage Therapy Boards (FSMTB) to support the mobility of licensed massage therapists through the development of a new interstate compact. This additional licensing pathway will create reciprocity among participant states and reduce the barriers to license portability.

Additional information discussed relating to the proposed International Massage Therapy Compact (IMpact) included:

- Compact Update and on August 17 at 12:00 CST regulation boards will attend virtual meeting regarding Impact.
- Carper opened discussion regarding education hours, does like state sharing discipline easily.
- Chiles provided an overview of the draft compact specifically what is required to qualify for a
 Multistate License under this Compact, and to maintain eligibility for such a license:

 - 1. Hold an active, unencumbered license to practice Massage Therapy in the applicant's Home State:
 - 2. Have an active and unique identifying number, as determined by the Rules of the Commission;
 - 3. Have completed at least six hundred and twenty-five (625) clock hours of Massage Therapy education, as approved under the laws of the applicant's Home State, or that Home State's Licensing Authority, or which the Commission may otherwise approve by Rule. Licensees holding an active and unencumbered license may be exempted from this requirement, as provided for by the Rules of the Commission;
 - 4. Have passed a national licensing examination developed and administered by a national Association of Massage Therapy regulatory boards or as otherwise approved by Commission Rule; 5. Have not been convicted or found guilty, or have entered into an agreed disposition, of a felony offense under applicable State or federal criminal law, within five (5) years prior to the date of their application, where such a time period shall not include any time served for the offense, and provided that the applicant has completed any and all requirements arising as a result of any such offense; 6. Have not been convicted or found guilty, or have entered into an agreed disposition, of a
 - misdemeanor offense related to the Practice of Massage Therapy under applicable State or federal criminal law, within two (2) years prior to the date of their application where such a time period shall not include any time served for the offense, and provided that the applicant has completed any and all requirements arising as a result of any such offense;
 - 7. Have not previously held a Massage Therapy license which was revoked by, or surrendered to, an applicable Licensing Authority;
 - 8. Have no history of any Adverse Action taken by applicant's Home State Licensing Authority within two (2) years prior to the date of their application;
 - 9. Have not been convicted or found guilty, or have entered into an agreed disposition, of any offense, whether a misdemeanor or a felony, under state or federal law, at any time, relating to any of the following: a. Kidnapping; b. Human trafficking; c. Human smuggling; d. Sexual battery; or e. Any other category of offense which the Commission may by Rule designate.
 - 10. Pay all required fees related to the application and verification or certification process, and any other fees which the Commission may by Rule require; and
 - 11. Comply with any and all other requirements which the Commission may provide.
- Concern voiced from AMTA-NE regarding education qualifications to participate in the compact is a minimum of 625 hours and Nebraska requires 1000 hours.
