Ratification of E-Mail Ballots Since the Last Meeting

Staff read the e-mail ballot since the last meeting on May 9, 2022, into the record as follows:

LEGISLATION UPDATE

Tomlinson asked Marcia Mueting, R.P., PharmD, Nebraska Pharmacists Association (NPA) if there was any discussion on legislative issues for the next legislative session.

Dr. Mueting explained that the NPA Legislative Committee will be meeting on September 15, 2022, to discuss and prioritize the members legislative wishes. Two legislative topics are pharmacy technician's administering immunizations and pharmacy benefit managers.

REGULATIONS UPDATE

172 NAC 131

Mr. Cushman provided the Board members with the hearing summary for 172 NAC 131. The Board members discussed comments. Teresa Hampton, Department Attorney will help Cushman with language regarding comments made about third party logistics providers under comment #2 of the hearing summary. Otherwise, the Department explained that the other comments required no changes.

Kester moved, seconded by Larimer, to approved 172 NAC 131 draft regulations as discussed. Voting aye: Beck, Kester, Klein, Larimer, and Tomlinson. Voting nay: none. Motion carried.

172 NAC 134

Mr. Cushman provided the Board members with the hearing summary for 172 NAC 134. The Board members discussed the comments individually. There were several comments that the Department identified will require no changes based on current statues. The Board discussed comments that identified the "consultant pharmacist" and suggested changing these to "delegating pharmacist" so the regulations would be more in-line with the current statutes. Another comment was made regarding grammatical errors, these errors

were corrected. Section 007 will make sure any references to "continuing education" and "inactive status" be removed as these terms are not applicable to these regulations.

Larimer moved, seconded by Kester, to approved 172 NAC 134 draft regulations as discussed. Voting aye: Beck, Kester, Klein, Larimer, and Tomlinson. Voting nay: none. Motion carried.

Mr. Cushman explained that he is still waiting on feedback regarding the last draft of 175 NAC 8 regulations.

Clarification Regarding Remote Dispensing Supervision (Marcia Mueting, RP, PharmD)

Dr. Mueting provided background to the request for clarification regarding remote dispensing supervision. Kester believed that adding a Clarification could be helpful. Dr. Dering Anderson commented that is it not correct that if language is not explicit than it is not required. Hampton explained that the intent could be that the supervising pharmacist be within the borders of Nebraska, however the law should be updated for changes in technology and scenario changes. Larimer commented that his opinion would be that the supervising pharmacist does not necessarily have to be within the confines of the supervising pharmacy but should be within the borders of Nebraska and that audio and visual connections works both ways from each location to include where the supervising pharmacist is located at. The Board asked Dr. Mueting if the NPA would be willing to create a work group to discuss this issue.

What Changes Can be Made to a Controlled Substance Prescription (Marcia Mueting, RP, PharmD)

Dr. Mueting explained that there was a newsletter from February 2009 that discussed what changes could be made to a controlled substance prescription which includes what changes could also be made after discussion with the prescriber. The Board agreed that nothing has changed since the 2009 article was written. Therefore, the Board's opinion is unchanged. Hampton commented that the State does not enforce federal law.

Dr. Pekny and Ms. Reuter provided a presentation regarding the need of Naloxone dispensing within their community. Naloxone is not a controlled substance but a prescription is still needed to dispense it. Hampton suggested revising their presentation, there is need for more specific facts, so the Department can give an opinion. There was mention that the hospital could apply for a delegating dispensing permit and Naloxone could be added to the formulary used be delegated dispensing permits. Board agreed to review Naloxone being added to formulary via email ballot.

Dr. Dering Anderson explained the scenario regarding a recent student that took the Nebraska Multistate Pharmacy Jurisprudence Examination (MPJE). She provided number of calls she had received regarding the examination for the past several years. Beck mentioned that there had been discussion at the District V meeting encouraging all states to update their pool of questions for their state's MPJE. Cushman explained that the Pharmacy Inspectors are scheduled to participate in NABPs meeting for updating

Nebraska's pool of questions for the Nebraska MPJE.

NABP - DISTRICT V MEETING (AUGUST 2022) - REPORT

District V meeting discussions included discussing needed changes to the State's MPJE. Beck explained that Accreditation Council of Pharmacy Education (ACPE) suggested that all state's stop requiring the MPJE for licensure. Other discussion included offering the state MPJE after the third year of education.

NABP - DISTRICT V MEETING - NEBRASKA TO HOST IN AUGUST 2024 - INITIAL PLANNING

The Board members decided that the meeting should be held in Omaha on the first weekend in August. Mr. Cushman and staff will begin initial planning.

The next Board of Pharmacy meeting is scheduled for November 7, 2022.
