### **MEETING MINUTES**

**October 20, 2023**

### **A. Composition of a Board of Medicine and Surgery Newsletter.**

Vonda Apking will prepare a draft of the newsletter that Dr. Hedrick presented to the Board for the first edition of the newsletter. The Board will review/approve the draft at the next meeting in December. The Board approved draft will then be presented to the DHHS Legal Department prior to publishing.

It was mentioned that there may be an alternative to discipline for ALL licensees. The Nebraska License Assistance Program (LAP) is a benefit for Nebraska health and health-related service licensees, certificate holders and registrants. It basically is another approach to a Physician Health Program, with the exception that it is available for ALL licensees not just physicians. Because licensees may not be familiar with the LAP the Board feels this will be an excellent topic to discuss in more detail in one of the future newsletters.
